As the Executive Director of the 2019 Ms. MSU Scholarship Pageant, I am excited to invite you to nominate up to four (4) women to represent your organization as a preliminary nominee. From this group, fifteen will be selected to compete for the title of Ms. MSU 2019.

Each nominee must be a student and must have and maintain an overall cumulative GPA of 3.00. They must also be planning to attend Murray State University as a student for the entire school year following the pageant (will not graduate before Spring 2020).

The applications are due on November 15th at noon in the CSI Office. There will also be a mandatory meeting for all applicants on November 15th at 5:00 pm in the CSI office. If the applicant is unable to attend, they may send a designated representative. Each nominee will have a 3-minute interview with a panel of judges on November 29th, 2018. Through the interview process the judges will select 15 contestants and 2 alternates to compete in the pageant on April 13th, 2019. If your nominee is chosen as a contestant, your organization will be asked to pay a \$50 entry fee.

The Ms. Murray State University Scholarship Pageant is a cherished tradition on this campus, which is why we ask that you choose nominees carefully. They should exemplify the characteristics of a model student and upstanding citizen and be able to represent both your organization and the university with respect and dignity.
